Can it Happen? A Chronology

- 1985
- Jun 14: TWA Flight 847 Hijacked
- October 7: Achille Lauro Cruise Ship hijacked by Palestinian Liberation Front. Passenger Leon Klinghoffer shot dead
- October 10: Egypt Air Flight 648 Hijacked by Abu Nidal Group, flown to Malta where Egyptian Commandos storm the plane 60 are killed by gunfire and explosives
- December 27: Rome and Vienna Airport attacks
- 1986
- April 2: TWA flight 840 bombed on approach to Athens. 4 American passengers and one infant killed
- April 6: The La Belle Discotheque in Berlin, a known hangout for U.S. Soldiers is bombed killing 3 and injuring 230 people. Libya is held responsible
- Sept 5: Pam Am flight 73 is hijacked and 22 people die
- 1988
- Dec 21: Pan Am Flight 103 bombing over Lockerbie, Scotland. The worst act of terrorism against the U.S. prior to Sept. 11, 2001

- Sept 19: Suicide Bomb destroys UTA flight 722 killing 171 passengers and crew
- 1993
- Jan 25; Mir Aimel Kansj, a Pakistani, fires an AK 47 assault rifle into cars waiting at a stoplight in front of the CIA head quarters. 2 die
- Feb 26; World Trade Center Bombing kills 6 and injures more than 1000 people
- June; Failed New York City landmark bomb plot
- 1994
- July 18: Bombing of Jewish Center in Buenos Aires, Argentina kills 68 wounds 300. Hezbollah acting on behalf of Iran
- July 19: Alas Christmas flight 00901 is bombed, killing 21
- July 26; Israeli Embassy attacked in London and a Jewish Charity car bombed wounding 20
- Dec 11; a small bomb explodes on board Philippine Airlines Flight 434
- 1995
- Jan 6: Operation Bojnka; Discovered on a laptop computer in Manila, Philippines
- July – October; Bombings in France killing 7 wounding 107
- Nov 13. bombing of Military Compound in Riyadh, Saudi Arabia

- 1996:
- June 25: Khoban Tower Bldg Dharan, Saudi Arabia kills 14 service men wounds 100's
- 1997
- Feb 24: Armed me open fire on tourists: hand written note: Punishment against the enemies of Palestine
- Nov 17; Islamic gunmen attack tourists Luyor, Egypt 62 dead
- 1998
- Aug 7: US Embassy bombings in Dar es Salaam, Tanzania and Nairobi, Kenya killing 225 and wounding more than 4000
- 1999
- Dec; Jordanian Authorities foil a plot to bomb US & Israeli tourists in Jordan. 28 suspects linked to part of the 2000 Millennium attack plots
- Dec 14; Ahmed Rissan arrested on US/Canadian Border in Port Angeles, WA – confesses to planning to bomb the Los Angeles International Airport
- 2000
- Over 30 attacks in Israel. The last of the 2000 millennium attack plot fails – a boat meant to bomb the USS Sullivan sinks
- Aug 9 ; Suicide bomber in Jerusalem
- October 12; USS Cole bombing kills 17 US Soldiers

Can it Happen? A Chronology

- 2001:



- Sept 11: killed almost 3000 WTC, Pentagon, Pennsylvania
- Attacks in Israel too numerous to detail. Death toll 203 and hundreds injured
- Parris Embassy attack plot failed
- American Airlines flight 63; Richard Reid attempts to destroy plane with a shoe bomb but is subdued by passengers and flight attendants
- Since then, not a week goes by without an militant Islamic terrorist attack or the thwarting of an attack somewhere in the world

What is Sharia?

- The *Deen* or rules of life sanctioned and ordained by Allah and reflects what is acceptable and unacceptable in Islam
- According to the Quran, Sharia is, “. . . a straight path . . . And endless supply of water” (45:18)
- Sharia is a complete way of life – religious behavior, personal, social, cultural, political, military.

What is Sharia Compliant Finance?

- Financial investments and transactions that are structured so that they are authorized and legal according to Sharia.
- Islamic scholars deemed knowledgeable on Sharia must approve and endorse the product for it to be pure (*halal*)
- Companies, organizations, and institutions that are Sharia compliant or offer segments of Sharia compliant products must have Sharia advisors, usually in board level positions to deem the products *halal*



Sharia Financial Restrictions

- Sharia is an “asset” based system
 - It completely rejects the notion that money can earn money
 - Money is simply a medium of exchange
 - “What is prohibited is any claim to the time value of money as a predetermined quantity calculable at a predetermined rate. . .” (Ayub 2007)
 - Money cannot be traded forwarded or speculated on.
 - Money can’t be loaned out with the expectation of a fixed return at a specific point in time.

The Cultural Financial Impact



In practice, this means. .

- - No more hedge funds, no more futures, no more market speculation, no more risk taking.
 - According to modern day interpretations, Sharia prohibits interest – both charging *and receiving*. This has not always been the case.

In practice this means. . .

- No more home ownership – loans become like leases where the bank owns the property and “rents” it to the person for a specified number of years. At the end of that time, if the person has complied with all of the bank demands, they get the title. The Banks profit technically comes from “renting” the house not lending the money.



In practice this means. . .

- Severe restrictions on business and organizational transactions, investments and activities which are forbidden if not *halal*.



Impure (*haram*) Activities

- Anything to do with:
 - Pork
 - Gambling
 - Pornography
 - Tobacco
 - Music
 - Drugs
 - Western defense

Zakat

- One of the five pillars of Islam and traced to the Quran verse 9:60
- Obligation for Muslims to pay 2.5% of profits and income to Muslim charities. Since Islam is a way of life, this encompasses all Muslim entities from the individual to the organization.
- It is not permissible to give Zakat to a non Muslim (Umdat at-Salik, h8.24)

So what is the problem with Zakat?

- According to Sharia, there are 8 categories of recipients for Zakat, one of which is, “*Those fighting for Allah [jihad].*”
- As a result, Zakat can and does produce funds for terrorism.
- In a report prepared for the President of the Security Council of the United Nations In 2002, Jean-Charles Brisard describes how such Zakat funded al Qaida:

Zakat Funding Terrorism

- At the root of that situation is an unresolved dilemma that turned to a
- confusion between religion and finance in the Kingdom of Saudi Arabia. By
- mixing religious beliefs, tools and interpretations with financial purposes,
- without proper regulations and controls, Saudi Arabia opened an avenue for
- terrorism financing through the traditional Zakat, a legal almsgiving conceived
- as a way for purification by the Prophet that turned into a financial tool for
- terrorists.
-
- Abusing this pillar of Islam and benefiting from the Saudi regulatory vacuum,
- al-Qaida was able to receive between \$300 million and \$500 million over the
- last ten years from wealthy businessmen and bankers representing about 20%
- of the Saudi GNP, through a web of charities and companies acting as fronts,
- **with the notable use of Islamic banking institutions. Most of this financial**
- **backbone is still at large and able to support fundamentalist organizations.** (Brisard,
- 2002, p. 3.) (Emphasis added).

How Much does “Terror” Cost?

- 1998 African Embassy Bombings > \$30,000
- 2000 USS Cole Bombing \$5000 - \$10,000
- 2001 Sept 11, 2001 2001 > \$500,000
- 2002 Djerba Bombing \$20,000
- 2002 Limburg Bombing \$127,000
- 2002 Bali Bombing \$74,000
- It is estimated that the Global Islamic Banking Industry has over \$1.5 trillion currently and is growing 10% to 15% per year. (Choudhury, 2010).



Sharia Undermines Western Societies and their Capitalistic Markets

- Destruction of the Capitalist society: What happens to an interest based capitalist society when not only the interest base is destroyed but the value of the asset to which the interest was tied is also significantly diminished?
- 

Sharia Undermines Western Societies and their Capitalistic Markets

- Freedom to Choose: In terms of business, organizations and products, what is acceptable (*halal*) and unacceptable (*haram*) is determined by a board of Sharia Advisor's schooled in Islamic law.
- One of the basics of the American Dream – business.
- By participating in Sharia Compliant Institutions, people are in essence submitting themselves to Islam and its dictates.

- The American Dream of owning your own home diminished.
 - Instead, Sharia Mortgages

- Risk taking – long held cultural value of the US.
 - The higher the risk, the greater the reward.

Sharia Undermines Western Societies and their Capitalistic Markets

- Destruction of Democracy by unwittingly funding terrorism against the West:
 - Sharia Compliant Finance networks allow and enable “legal” financial transactions with Western banks and financial institutions that in essence fund terrorism in the West.
- 

Sharia Undermines Western Societies and their Capitalistic Markets

- Destroying the separation of church and state:
- AIG is the largest holder of Sharia Compliant Insurance in the world. They were bailed out with American tax payer dollars.
- Every American tax payer is a part owner of an organization that promotes Sharia Complaint Financing and Sharia.

Sharia Undermines Western Societies and their Capitalistic Markets

- Destroying the separation of church and state:
- Giant Mortgage investor Freddie Mac began buying Sharia compliant Mortgages in 2001.
- They bought more than \$250 billion in Islamic Mortgages in 2007 alone. (Wiseman, 2008)
- Freddie Mac was bailed out with American tax payer dollars and is now under federal government conservatorship.
- Every American tax payer is part owner of organizations that promote Sharia Compliant Financing.



Sharia Undermines Western Societies and their Capitalistic Markets


- We need only look to Europe to find the answer:
- The UK is home to the first wholly Sharia Compliant retail bank in the west, Islamic Bank of Britain, which was authorized by the Financial Services Authority [FSA] in 2004. . . . The UK now has five fully “Sharia Compliant banks . . . while another 17 leading institutions, including Barclays, RBS and Lloyds Banking Group have set up special branches or subsidiary firms for Muslim clients. (Choudhury, 2010, pp 1-3)

- As a final note on the financial impact of Sharia Compliant Finance, “what is important to grasp is that Islam recognizes no authority superior to Sharia Law. When trillions of pounds and dollars are locked into them, Sharia banks will not recognize the superior authority of the law of the land” (Choudhury, 2010, p. 1). (Emphasis added). An Explanatory Memorandum

- An Explanatory Memorandum On the Strategic Goal for the Group in North America.
- Actual evidence acquired by the FBI during a raid in Annandale, Virginia and entered into evidence in 2004 in the trial of the United States versus HLF (Holy Land Foundation) (A terrorist organization under cover of a “Muslim Charity Organization” operating out of the United States.
- Written by Mohamed Akram, a member of the Board of Directors for the Muslim Brotherhood in North America and also a senior Hamas leader.
- The document and its directives were approved by the Brotherhoods Shura Council and Organizational Conference.

An Explanatory Memorandum

- Among other things, it outlines the mission of the Muslim Brotherhood and its helpers in North America.
- The process of settlement is a “Civilization Jihadist Process” with all the word means. The *Ikhwan* [Muslim Brotherhood] must understand that their work in America is a kind of grand jihad in eliminating and destroying the Western Civilization from within and “sabotaging” its miserable house by their hands and the hands of the believers so that it is eliminated and God’s religion is made victorious over all other religions. - Four Overarching Directives:
- 1) Know about the West in order to destroy it
- “the art of dealing with others” so that by so doing you can “take from people . . . the best they have, their best specializations, experiences, arts, energies and abilities . . . within and without the ranks of individuals and organizations” (p.8).

An Explanatory Memorandum

- In the 1990's Muslim student attendance reached critical mass and continues to climb.
- Grossmont college has seen a large increase in its Muslim student population.
- "This past school year, Saudi Arabia sent 66,000 students to U.S. Universities, four times the number before the 2001 attacks and the fastest growing source of foreign students in the U.S., ahead of China according to the Chronicle of Higher Education." (Knickmeyer, 2012, A1)

An Explanatory Memorandum

- Many Muslim students practice self-segregation and stick closely with other Muslim students through the organization Muslim Student Association (MSA) rather than integrating. Segregation has its roots in the Quran:
 - Let not the believers take the disbelievers as friends instead of the believers, and whoever does that, will never be helped by Allah in any way, unless you indeed fear a danger from them. And Allah warns you against himself, and to Allah is the final return. 3.28

- 2) Building and Using Religious Mosques to Gather and Plan
- This category includes the creation of “The Islamic Center” in every city to provide a place where selection of workers for “role distribution” and “assigning” positions and responsibilities for the success of the “settlement.” (Civilization Jihad)

An Explanatory Memorandum

- Study: "Sharia Adherence Mosque Survey: Correlations between Sharia Adherence and Violent Dogma in US Mosques, " 51% of the 100 mosques surveyed had text on site rated as severely advocating violence and 30% had texts rated as moderately advocating violence while only 19% had no violent texts at all (Kedar & Yerushalmi, 2011).


An Explanatory Memorandum

- Mosques and Sacred Space in Islam
- According to Sharia the entire earth was given by Allah to Muslims. Recreating that sacred space on new or reclaimed territory for Islam is a continuous and ongoing process (Sookhdeo, 2007)
- Mosques and Islamic Centers are erected on top of conquered enemy territory and destroyed sacred spaces of other religions.
- Hagia Sophia Mosque in Istanbul (Formerly the Cathedral of St. Sophia in Constantinople)
- Al-Aqsa Mosque and Dome of the Rock Mosque (Both built on Jewish Temple Mount on top of Jewish Temples)

An Explanatory Memorandum

- Cordoba Mosque Complex (Formerly a Christian Cathedral)
- \$100 million, 13 story Islamic Center and Mega-Mosque two blocks from Ground Zero in New York City, the site of the World Trade Center, which was destroyed in the jihadist attacks on September 11, 2001.

- 3) The Establishment and Use of Muslim Organizations in the West
- The Muslim Student Association (MSA) is on this list. In the MSA's Starters Guide, there is an open call Islamicize Campus politics:
- It should be the long-term goal of every MSA to Islamicize the politics of their respective university . . . the politicization of the MSA means to make the MSA more of a force on internal campus politics. The MSA needs to be a more "In-your-face" association. (MSA Starter's Guide, 1996)

An Explanatory Memorandum

- 4) The Growth and Development of Financial and Human Resources
- educational, political, media including Art Organization, economically – including the establishment of Sharia Compliant Finance and an Islamic Central Bank, Scientifically and professionally, cultural and intellectually, socially and socially charitable, youth organizations, women organizations – including training both “vocational and *housekeeping*,” organizationally and administratively, security – including clubs for training self defense and security issues both technical and human, and legally – including an Islamic Foundation for the Defense of Muslims Rights

Sharia vs. U.S. Constitution

- The Preamble:
- “We the people . . .
- The People are the founding entity, authors of the constitution, and determine rights and liberties in America.

Under Sharia, Allah is the founding entity, and he, through the Quran is the author and director rules in life, rights and liberties.

Sharia vs. U.S. Constitution

- Article VI
- "... This Constitution ... Shall be the supreme law of the land, ..."
- The adoption of Sharia Compliant Financing requires adherence to Sharia Law and does not recognize any law of the land above Sharia.

Sharia vs. U.S. Constitution

- The First Amendment: . . . No law respecting an establishment of religion . . .
- Rather than the original intent – tolerance for ALL religions, this amendment is being used to subvert the American Constitution under the guise of “religious persecution.”


- In several court cases, Judges have used Sharia and foreign law in their rulings.

Sharia vs. Freedom of Speech



Sharia vs. Freedom of Speech

- To counter terrorism:
- Many Americans, organizations, and institutions are offering “apologies” for “offending” Muslims by presenting “factual data.” The New York Police Department is a case in point. It offered a public apology to its Muslim Community (which they rejected as not good enough) for showing a video during officer counter terrorism training that depicts various aspects and threats of Sharia and its doctrines, including the recruitment of inmates to convert to the Muslim religion and Muslim Imams in the prisons calling for violent jihad.

Sharia vs. Free Speech

Sharia and “Tale Bearing”

- In accordance with the definition of “tale bearing” in *Reliance’s* chapter r2.6, the disclosure of any sensitive information to non-Muslims is forbidden, where sensitive means any information that puts Islam or a Muslim at a disadvantage. Hence, a Sharia compliant Muslim risks eternal damnation if he discloses to a non-believer information that would cause the non-believer to question either Islam or a Muslim. . . .For non believers, the corollary to the Islamic rule against disclosing anything disadvantageous to Islam is Sharia’s prohibition against blasphemy. This requires that infidels refrain from engaging in discussions about Islam that extend beyond what is permitted of them or would give offense to Muslims. (Sharia the Threat, 2010, pp. 104 – 105)

Sharia and Tale Bearing

- The Sharia prohibition against blasphemy is publically and legally enforced by Muslim Organizations and individuals through the use of the American courts via alleged violations of the First Amendment.
- Result? Public apologies, court judgments, fines and sanctions.
- Moderate Muslims refusing to speak out
- Ironically, the same amendment and laws that protect the rights of American Muslims to publically profess and promote hate toward America, its people, systems, and institutions while living here.


Lying for Islam - Taqiyya

- The Quran also offers directions on lying.
- It disapproves of Muslims lying to other Muslims, but permits lying to infidels when it would be advantageous, or lying for the sake of Islam, "taqiyya." (Center for Security Policy, 2010)
- This is why we continue to see our soldiers killed by Afghani coalition "friendly forces."
- Purposeful betrayal and deception

Sharia vs. Freedom of Religion

- The United States is based on freedom of religion. Allah, Islam, and Sharia will NEVER tolerate another religion.
- In her recent article, "The Rise of Christophobia," Ayaan Hirsi Ali, points out that "from one end of the Muslim world to the other, Christians are being murdered for their faith . . . terrorist attacks on Christians in Africa, the Middle East, and Asia increased 309% from 2003 to 2010 (2012, pp. 28-30).



Sharia vs. Freedom of Religion

- Apostasy
- According to the book "Reliance of the Traveller," "Leaving Islam is the ugliest form of unbelief and the worst. . . . Whoever voluntarily leaves Islam is killed. . . . When a person who has reached puberty and is sane voluntarily apostatizes from Islam, he deserves to be killed" (08.0 and 08.1) This view on apostasy provides another explanation of why "moderate" Muslims, non-affiliates, and ex-Muslims rarely speak out against anything Muslim including all forms of jihad.

Sharia vs. Human Rights

- Human rights have long been a cornerstone of American Culture but Islamic cultures endorse and execute some of the most horrific human rights violations in the world.



Sharia vs. Human Rights

- The Quran states:
- Men are created one step higher than women. (Quran 4.34)
- Good women should be obedient to their husbands. (Quran 3.4, 2.228)
- Men are permitted to beat women (Quran 4.34)

- Women inherit only half what a man inherits (Quran 4.11)
- Witness of two women equals witness of one man. (Quran 2.282)
- Male and female thieves should have their hands cut off (Quran 5.38)

Sharia vs. Human Rights

- **Stoning to death was ordered by Mohammad** and is a very cruel brutal punishment and its only aim is to inflict maximum pain on the individual.

Sharia vs. Human Rights

- Any religion except Islam will not be accepted. (Quran 3.85)
- Homosexuality is punishable by death. (Fatwa No. 38622 principles of Fiqh, Jurisprudence and Islamic Rulings, Punishments and judicial sentences, adultery fornication and homosexuality.)

Sharia vs. Human Rights

- Shaykh Muhammad s Al-Munajjid states that, “The crime of homosexuality is one of the greatest of crimes, the worst of sins and the most abhorrent of deeds . . . execute the one who does it and the one to whom it is done: . . . classed as saheeh by al-albaani in Saheeh al-Tirmidhi (Al-Munahjid)

Sharia vs. Human Rights

- According to the *International Lesbian and Gay Association* ILGA there are at least seven countries today which still retain capital punishment for homosexual behavior. All are predominately Muslim countries. They are: Afghanistan, Iran, Mauritania, Pakistan, Saudi Arabia, Sudan, and Yemen.

Sharia vs. Human Rights

- Muslim Honor Killings
- Not just in nations ruled 100% by Sharia such as Iran, Saudi Arabia and Sudan, but right here in North America – Canada and the U.S.
- In Canada on January 30, 2012, “two Afghan immigrant parents and their son were found guilty of murdering four female family members in a so called honor killing,” (McDonald, 2012, p. A9)

Sharia vs. Human Rights

- Honor Killings
- One here in El Cajon?
- During Spring Semester 2012– Muslim woman killed in her own kitchen– beaten in the head with a blunt object. Note left, “go back where you came from.”
- The media calls this a racist, Islamaphobia killing.
- Because he was not a suspect at the time, the police allowed the husband to leave the U.S. with the children and the wife’s body for a burial in their home country.
- Later police discover that the woman had papers to file for divorce in her car and that the father was forcing the older daughter into an arranged marriage.
- There has been no further media coverage. Did the father and children not return?

Sharia vs. Human Rights

- How and why do such atrocities continue?
- The answer – silence, tolerance, and blind acquiescence.
- Sharia Law: She's Buried Chest High
- Despite the US effort in Afghanistan, a recent article headline read, “Afghan Women Seen as Losing Ground.” “Most of women’s important achievements over the last decade are likely to be reversed. . . Including the right to vote, hold public office, and get an education.” (Levinson, 2012, A12)

Sharia vs. Human Rights

- Another recent article head line read, "Egyptian Mob Attacks Women: March in Cairo demanding an end to sexual assaults becomes violent," . . . A mob of hundreds of men assaulted women . . . The marchers (women) tried to flee . . . But attackers persisted, cornering several women against a metal side walk railing, including an Associate Press Reporter, shoving their hands down their clothes and trying to grab their bags. . ."
(Batrawy, 2012, A4)

- As you know, Mohamed Mursi, a leader of the Muslim Brotherhood, was elected President of Egypt after the Arab Spring toppling of Mubarak.

The Professors


- Professor Ihsan Bagby, University of Kentucky, Islamic Studies (Convert to Islam)
